11. Enabled at Pharmacist Care Clinics.

12. Enabled at Community Pharmacy Primary Care Clinics and some primary care and hospital settings.

13. Authority limited to ordering blood tests. No authority to interpret tests.

14. Pharmacy technician registration available through the regulatory authority (no official licensing).

15. In cases of supply interruptions, market withdrawal, patient safety concerns requiring urgent treatment without prescriber access, or medication administration difficulties.

16. May administer medication (SC, IM, ID) route to demonstrate proper injection techniques or in emergencies requiring immediate intervention until first responders arrival.
