Call for Presentations Now Open!

Pharmacy Experience Pharmacie 2019 (PxP2019) is a new conference brought to you by the Canadian Pharmacists Association (CPhA) and the Ontario Pharmacists Association (OPA). Together we invite you to share your expertise with Canada's pharmacy community next June 2-5, in Toronto.

We are striving to create a dynamic and interactive program that inspires a broad and exciting discussion about pharmacy practice and pursuit of excellence in patient care and the impact of pharmacists within the Canadian health care system at large. Submissions should reflect this vision.

Call for presentations closes **Sunday, December 16, at 11:59 p.m. ET**. Please read the following before continuing to the submission link. (**NOTE**: A separate call and submission process for Pharmacy Practice Research abstracts will open at a later date. **Do not** use this process to submit a research abstract.)

About the Conference

PxP2019 replaces both CPhA's and OPA's individual conferences. This inaugural event will be an opportunity for Canada's pharmacy community to come together to learn, connect and be inspired about pharmacy as a profession, a practice and a calling. From big picture perspectives to practical takeaways, PxP2019 will feature engaging sessions that encourage delegates to share their experiences and learn from each other.

The conference is expected to attract more than 1,000 delegates including:

- · Community, primary care, hospital, academic, research, regulatory, military and corporate pharmacists
- Pharmacy technicians and assistants
- Industry executives
- Students and interns

Submission Guidelines

The Conference Education and Research Committee (CERC) is seeking proposals for presentations in the following areas. Presentations should focus predominantly on application of knowledge into practice and practical takeaways.

- Recent Evidence in Primary Care
- Updated Guideline Recommendations (specify)
- Pharmacy Quality Indicators
- Leadership/Mentorship
- Motivational Interviewing
- Artificial Intelligence/Automation/Technology and its impact on pharmacy
- Innovation in Practice or Management
- Pharmacy Professional Health and Wellness (e.g., how to overcome burnout)
- Reducing Stigma in Patient Care

- Scope and Remuneration: Delivery Methods
- Inter- and Intra-Professional Collaboration in Pharmacy Practice
- Pharmacy Care in Vulnerable Populations

Additional proposal topics are welcome.

CERC is looking for presenters with strong facilitation skills who will offer alternative delivery styles for their session, e.g., interactive, conversational, roundtables, fireside chats.

Presentation Criteria and Presenter Information

Presentation proposals will be accepted until 11:59 p.m. ET, on Sunday, December 16, 2018. Only proposals sent via the submission link below will be considered. We encourage presenters to submit multiple proposals for multiple topics. Notification of status of submission(s) will start in January 2019.

Proposals will be reviewed and evaluated by CERC based on the following criteria:

- Interest and value to conference participants on either a national or provincial level
- Session format incorporates interactive learning opportunities and an innovative delivery style
- · Learning objectives are clear, specific, immediately applicable and supported by the content presented

Session length: 60 minutes (45-minute presentation, 15-minute Q&A).

Presenter availability: at the time of submission, presenters must know they will be available to present on any day, at any time within the program schedule (June 2-5). CERC will finalize date and time with selected presenters in early 2019.

Multiple proposals: may be submitted but must be sent individually.

All submissions must be sent electronically using the link provided. Proposals of a commercial nature that promote or market products and/or services will not be considered. Due to the volume of proposals that PxP organizers receive, submission does not guarantee inclusion in the conference program. Where possible, PxP organizers will consider submissions for future educational opportunities.

Before completing the submission form, please ensure you have:

- Reviewed the Submission Guidelines (see above)
- The name, credentials, contact information, email address and 50-word bio for each presenter (maximum of two presenters)
- Drafted your submission including title, format, description, learning objectives, key audience and relevance to a national pharmacy experience.
